

Beasley Gaming Series: Mortal Kombat Tournament OFFICIAL CONTEST RULES

These rules apply to Beasley Gaming Series: Mortal Kombat Tournament (“Contest”) conducted by Beasley Media Group, LLC d/b/a WPBB, WLLD, WYUU, WRBQ, & WQYK (each a “Station,” collectively the “Stations”). **In addition, the General Contest Rules posted at www.wild941.com, www.987TheShark.com, and www.925maxima.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on 10/04/2021 and end on 10/24/2021.
- b. To register online, visit www.wild941.com, www.987TheShark.com, and www.925maxima.com and follow the links and instructions to register for the Contest and complete and submit the online registration form beginning on May 31, 2021 at 12:00am Eastern Time (“ET”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) registration per eligible person regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. **The first eight (8) entrants (“Participants”) who submit an online registration form will be selected to participate in the “Prize Tournament,” as described in Section 4 of these Official Rules, on a first come, first serve basis. Four (4) additional entrants (“Alternates”) will also be selected on a first come, first serve basis to serve as alternates in the Prize Tournament.**
- c. There will be up to a total of one (1) First Place Prize winner and one (1) Second Place Prize winner selected in this multi-Station Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the State of Florida, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) First Place Prize will be awarded. The First Place Prize consists of a five hundred dollar (\$500) Visa gift card. Approximate Retail Value (“ARV”) of the First Place Prize is \$500.
- b. Up to one (1) Second Place Prize will be awarded. The Second Place Prize consists of a two hundred fifty dollar (\$250) Visa gift card. ARV of the Second Place Prize is \$500

- c. The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card. Gift cards are not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.

4. SELECTION OF WINNERS

- a. Up to eight (8) Participants and four (4) Alternates will be selected on a first come, first serve basis, as described in Section 1, to participate in the Prize Tournament. Participants and alternates will be notified before 4pm on 6/17/21 if they have been selected to participate in the tournament.
- b. All Participants and Alternates will be required to be present at the Prize Tournament on 06/29/21 at 4pm ET. Any Participants not present by 4p ET will be disqualified at the sole discretion of the Station, and the first Alternate will be selected to participate in the Prize Tournament in their place.
- c. The Prize Tournament will be conducted in accordance to Addendum A. Station reserves the right to change the tournament format in their sole and absolute discretion. All tournament equipment, including consoles and gaming controllers, will be provided. Participants will not be permitted to use their own equipment.
- d. Entrants need not listen to the Station but must be present to participate in the Prize Tournament for the opportunity to win a Prize.
- e. Decisions of Station management with respect to the Contest are final.

Tournament Guidelines

All Settings Used Will Be the Default Settings, Unless Otherwise Noted

THE TOURNAMENT FORMAT

- Tournaments will be either Single Elimination
- Each match will be the Best-of-3 Games

CHARACTER SELECTION

- The winning player, of the preceding match, will choose their character first, for the upcoming round
- The losing player, of the preceding match, will choose their character last, for the upcoming round

IN-GAME SETTING

- Game Timer: 90 seconds
- Tournament Mode Default Options
- Arena Select: Off
- Interactable: On
- Variations: Tournament Mode Variations

LEAVING GAMES EARLY

- We highly discourage participants from quitting and leaving matches early. We understand that some games might be lopsided throughout the tournament. We want this to be a fun experience for everyone and if you commit to participating in the tournament, the expectation is for you to finish all your matches to their conclusion.
- Each match will have the results submitted at their conclusion and we will note those individuals who quit early. If this becomes a theme, we will penalize you and not allow you to participate in future tournaments.

SPORTSMANSHIP POLICY

1. Having good sportsmanship is expected during competition.
2. If sportsmanship continues to be an issue, you will be removed from competition
3. Violence will not be tolerated.
